


**Certification of Temporary Amendment to the Bylaws and Rules of
Queens County Republican Committee**

We do hereby certify that the Executive Committee of the Queens County Republican Committee, by a unanimous vote with a quorum present at a meeting held in accordance with Executive Order 202.13 pursuant to Chapter 38 of the Laws of 2021, amended the rules of the Queens County Republican Committee, to wit:

Temporary Rule pursuant to Chapter 38 of the Laws of 2021:

"The members of the County Committee whose terms shall otherwise end in 2021 shall remain in such party position for an additional one year term without election thereto, and such County Committee members' positions shall be duly elected in 2022 as provided for in the Election Law for a one year term. In 2023, and thereafter, such County Committee members shall run for two year terms. This rule shall be effective until the end of 2023, and shall apply only as provided herein, consistent with Chapter 38 of the Laws of 2021."


